

KHutch Investigations Contract

This agreement is made and entered into on the ____ day of _____, 2010, by and Between _____(hereafter referred to as CLIENT) and KHutch Investigations(hereafter KHI)

1. KHI shall perform the following service(s) for CLIENT _____

2. CLIENT agrees to pay KHI a rate of **\$50.00** per hour for first investigator and **\$25.00** per hour for each additional investigator for performance of services for CLIENT.
 - (a) In addition, CLIENT agrees to pay KHI a retainer fee of \$ _____(the minimum charge for services, by KHI). Upon consumption of said retainer fee, CLIENT agrees to pay additional sums as requested by KHI for completion of services requested. KHI agrees to inform CLIENT of expenses and charges incurred as result of performance of services.
 - (b) CLIENT also agrees to pay KHI for all additional costs incurred at the following rates:
Surveillance vehicle mileage **\$.50** per mile, car mileage **\$.50** per mile, **\$15.00** per requested video beyond the video furnished with the report. CLIENT also agrees to pay incidental costs such as food, lodging and additional expenses as they may occur during performance of services. CLIENT shall advance or reimburse accrued expenses upon request by KHI.
 - (c) For court appearances or stand by for court appearances, requested or required by CLIENT or CLIENT'S ATTORNEY (with or without a subpoena) or by other parties (only with subpoena or legal instrument) arising from services performed for CLIENT. CLIENT agrees to pay the sum of **\$50.00** per hour for first investigator and **\$25.00** for each additional (Four Hour Minimum). CLIENT agrees to pay **\$50.00** per hour for travel time to and from court and will also pay for vehicle mileage at a rate of **\$.50** per mile. CLIENT agrees to pay estimated expenses for court appearance at least 72 hours in advance (if requested). Time spent waiting to appear will incur same above charges if testimony is given or not.
 - (d) CLIENT agrees to pay KHI, in advance, if requested by KHI, for estimated charges and expenses associated with requested service. CLIENT also agrees to pay KHI within 14 days of billing date. If payment is not made before end of the 14 day period, CLIENT understands that a late fee of 1.5% of the balance will be charged per month to the CLIENT's bill. CLIENT also agrees to pay attorney fees and court costs resulting from collection of unpaid balance and interest on that balance. CLIENT agrees that legal jurisdiction for any action arising out of breach of any term in the contract be in Forsyth County, North Carolina.
3. KHI agrees to submit to CLIENT within 30 days of receipt of payment, a detailed written report (oral if preferred) of all information collected during the performance of services. All information relative to services rendered, will be held in confidence and be revealed only to CLIENT except as required by law.
4. KHI may rely on representations by CLIENT. CLIENT shall indemnify and hold KHI harmless from any liability that may result from any misrepresentation by CLIENT.
